President's Report

To propel the Senate to vote on H.R. 82, which seeks to repeal the windfall elimination provision affecting Social Security benefits, it is crucial to galvanize support and underscore the significance of this bill. Here are key strategies to consider:

- 1. Connect with advocacy groups, retirees, and individuals impacted by the windfall elimination provision. By fostering a united front, we can amplify our message of urgency and the bill's critical importance.
- 2. Highlight personal testimonies from those who would directly benefit from the repeal. These heart-felt narratives can resonate with lawmakers, illustrating the tangible effects of this legislation on constituents' lives.
- 3. Equip senators with comprehensive information regarding H.R. 82, its implications, and its positive potential. Tailored briefings or informational sessions can ensure they grasp the significance of their vote.
- 4. Use social media platforms to create awareness and excitement around H.R. 82. Encourage supporters to share their experiences and call on senators to take decisive action.
- 5. Organize Meetings**: Request direct meetings with senators or their staff to discuss the bill and express the strong backing it enjoys from constituents. Present facts, compelling arguments, and passionate appeals to make a definitive case.
- 6. Initiate letter-writing campaigns, phone banks, or public demonstrations to showcase widespread support for the bill. A robust grassroots effort can exert pressure on senators to prioritize this issue.
- 7. Engage local leaders, veterans' organizations, and retired teachers' associations to lend their voices to the initiative. Their influence can be pivotal in swaying lawmakers toward supporting the bill.
- 8. Stay vigilant regarding the bill's status and upcoming votes. Proactively rally support ahead of critical deadlines to ensure H.R. 82 remains a priority.

There were just a few days left on the legislative calendar to vote on this crucial legislation as of this writing.

As the State Association looks to 2025, we plan several LCCL trainings for January. We invite everyone interested in learning about what a Letter Carrier Congressional Liaison (LCCL) does. In addition to training, there are discussions on a legislative trip to lobby our members of Congress in Washington, D.C., in some part of 2025. We also look forward to seeing all branch presidents at the Texas State Committee of Presidents in Austin on 01/25/2025. Vice President's Report

With the 2024 general election over, few changes were made to the Congress, the Senate and the White House. In the state of Texas Donald Trump received 6,375,376 votes compared to Kamala Harris who received 4,806,474 votes. We will have a republican president in the White House for the next 4 years. In the Texas Senate race Ted Cruz received 5,973,431 votes and Colin Allred received 5,002,535 votes given Ted Cruz another term the Texas Senate. The US Senate will have 47 Democrats and 53 Republicans. The US house we have 214 Democrats and 220 Republicans this means the Republicans will control the Senate the house and the White House. This election cycle was not easy I just want to say thank you to all the carriers in the state of Texas that help campaign by knocking on doors block walking the phone banking your help was really appreciated.

HR 82 has finally made it through the Congress and is headed to the Senate. With the changes to the House and the Senate this bill which changes the Social Security status for millions of Americans will probably sit in the Senate until the new administration is sworn in. But we must remain ready if there is a call to action, please do not hesitate to contact your Texas senator so we can get this Bill to the president's desk and become law. Thank you again for contacting Your Texas House representative and getting this bill through the Congress.

Donald Trump has selected Republican Senate candidate from Oregon Lori Chavez DeRemer to head the department labor. Lori has been his strong advocate for unions and laborers. She is considered one of the most Labor friendly Republicans in Washington, she is one of the few GOP members of Congress to Co-sponsor the Protecting the Right to Organize (PRO) Act, a bill that will make it easier for laborers to organize a union. Let's continue to work with Lori and continue to make the labor movement stronger.

Director of Retirees' Report

January 2025

Greetings My Fellow Retired Brothers and Sisteral!

I sure hope y'all had a wonderful CHRISTmas filled with family and friends (and Santa was good to you) and have a GREAT 2025!

Civil Service Retirement System (CSRS) annuitants and survivors and eligible Federal Employees Retirement System (FERS) retirees and survivors will receive a COLA effective December 1, 2024. The increase will be reflected in your January 2, 2025, payment. CSRS annuitants will receive a 2.5% COLA and eligible FERS annuitants will receive a 2.0% COLA.

Let's make 2025 a year to be more Health Conscious. I'd like to ensure that all of you are around for a long time!! Self-care means taking the time to do things that help you live well and improve both your physical health and mental health. When it comes to your mental health, self-care can help you manage stress, lower your risk of illness, and increase your energy. Last month, the house voted to pass H.R. 82; please ask your senators to bring H.R. 82 to the floor for a vote. H.R. 82 would repeal the WEB and the GPO, that Social Security benefits of federal annuitants. There are other bills like H.R. 5995 Federal Retirement Fairness Act(FERS) that's for employees who started the post office in non-career positions and transition to career status must work longer to reach the required years to receive full retirement benefits. Keep door delivery (H. Res. 376) and USPS Shipping Equity Act (H.R. 3721/S.5069), Workers' Compensation for Injured Federal Workers Act. We also have (H.R. 7629/S.4356) Protect our Letter Carriers Act for crimes against letter carriers, in recent years it has doubled but arrests and convictions for their crimes, but arrests and convictions have not. The elections were in November and we have a hard road ahead of us. But, with that I want to wish everyone a Merry Christmas and Happy New Year. Be safe and we'll see January 25, 2025 at the TSLAC Committee of Presidents in Austin.

District 3 Report

Greetings from District 3!! As I write this article The United States Senate is back in session as of December 3, 2024. I urge everyone to reach out to fellow letter carriers and encourage them to contact Senator Cornyn and Senator Cruz to support HR 82 Social Security Fairness Act before they are scheduled to leave for the December 20th holiday recess. HR 82 would repeal the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO), which are parts of Social Security law that unfairly reduce or sometimes eliminates Social Security benefits of federal annuitants, including letter carriers. HR 82 passed in the House overwhelmingly and has strong bi partisan support. Please call Senator Cruz Office at (202) 224-5922 and Senator Cornyn Office at (202)-224-2934. Back home in District 3 I have been reaching out to Congressman Ronny Jackson's office and both Senator Cruz and Senator Cornyn's offices about legislation important to letter carriers. If you look on nalc.org under government affairs you will see a link for NALC's Priority Legislation pdf. When you open it you will see the 6 bills currently in the House and Senate. HR 7629/S 4356 Protect Our Letter Carriers Act is our top legislative priority. HR 82/ S. 597 is our second highest legislative priority. With HR 82 moving out of the house and on to the senate it is the bill closest to being passed by both chambers and then sent to the president for his signature. 3rd on the priority list is HR 5995 Federal Retirement Fairness Act. This would allow certain federal employees to make catch up contributions for the time spent as non -career employees after Dec 31, 1988, making such time credible service under the Federal Employee Retirement System. This includes letter carriers who served as casuals, transitional employees and city carrier assistants. This legislation is very important to me and to many members in our union. A lot of members have spent many years in a non-career status and time simply doesn't get added to our time as letter carriers for the postal service. I was a non-career employee for 2 years, 9 months and 11 days. When I converted to career, I wanted those years and months to be added to my actual time served as a letter carrier. It's a hard pill to swallow knowing that my time counting towards retirement was just then starting and not nearly 3 years back from when I first started. If I were able to buy back my non-career time, I would be able to retire earlier and add more to my annuity payment. This legislation is so important to CCA's, casuals and TE's and encourage all letters carriers to send a letter, email or call Senator Cruz, Senator Cornyn and your local congressman to support this legislation and support letter carriers. Look forward to seeing you all in February at the Spring School!!

The senate needs to vote on this bill before this session is over, as I feel that if it does not get done now, then it probably doesn't have much chance for at least 4 years. It will start from scratch. This bill, if passed, will also take care of two other legislative goals of N.A.L.C. Headquarters. The other bills that would be fixed by a passing vote would be the Windfall Protection Provision Act or the W.P.A. The other bill would be the Government Pension Offset or the G.P.O. as it is known. These two rules do more harm to employees than good. I'm sure you're asking how I can help. That is very easy to do by logging onto the N.A.L.C website and it will help you get to your Senators here in the state of Texas. You can also call your Senators' local offices. Ask them to support this bill if they can get a vote. The state assoc. is discussing a Washington D.C. Legislative trip. It is in the early stages of planning, so nothing has been decided. We, as a board, are discussing having 4 training sessions spread at different locations for the L.C.C.L.'s.
